To Contact Trustor For Park Approval

Next step in the transfer of approximately 831 acres of Palos Verdes park Jands from the Homes Association to the City of Palos Verdes Estates will be the asking of approval of Mr. Oscar L. Willett, Trustor of Palos Verdes Trust, to quitclaim the Trust's rights in the park properties. The Bank of America

Steps to gain this approval were decided upon with the appointment of a committee to contact Mr. Willett at the last meeting of the Board of Directors of the Palos Verdes Homes Association Wednesday evening, March 6. Col. Val E. Miltenberger of Miraleste, Dr. Dennis V. Smith and Mr. F. H. B. Roessler was the committee appointed. They will report their conference with Mr. Willett at the next borad meeting, Wednesday, March 20. March 20.

CITY ASKS FOR PARKS

Vice President A. P. Allen, presiding in the absence of President Ulric B. Bray, read a letter from the city formally asking the Homes Association to quitclaim to the city the park properties within the city limits. These park properties include the Shoreline and Swimming Club and the golf course. A letter was also read from Mr. Wright, trust officer of the Bank of America, that the bank would execute such a quitclaim if Mr. Willett approves.

BULLETIN

In asking for the park lands from the Homes Association the city gave their written assurance that all members of the Homes Association, including property woners in Miraleste, would retain rights in these parks and playgrounds upon the same basis as all residents of the city, and promising that the existing restrictions would be increased and enforced. existing restrictions w preserved and enforced.

OTHER BUSINESS

An objection from Paul W. Hiller of Miraleste was read concerning the board's handling of the matter of a vacated portion of Via Canada in Miraleste. At resent this property is being used by an individual in that territory as a public street. Board members adopted a resolution to consult the Association attorney as to the legal aspects of the use of the vacated portion. If the attorney's report states that Via Canada cannot be used as a public street, the board will obtain an injunction on restraining the individual.
