

# **SAVE OUR PARKLANDS & RESTORE DEMOCRACY TO THE P.V. HOMES ASSOCIATION. ELECT NEW LEADERSHIP!**

The current PVHA Board has self-appointed themselves and invalidated elections for nine-straight years. They've stifled open elections by supporting a 92-year old quorum that's too high, limited ballot mailings, failed to count the ballots and ignored a requirement to obtain 100 signatures for eligibility. The incumbents also seek to invalidate deed restrictions that prohibit the sale of Parklands and have sold Parkland illegally. Positions supported by the Nominees are shown below.
